Resolution Authorizing Budget Amendments
To The General Fund For the Fiscal Year Ending June 30, 2012.

WHEREAS, the Emergency Management Office has received additional grant funds to be expended for training of emergency responders on Hazardous Materials Incidents. The grant total is \$8,125 with a \$1,625 local match that will be provided with in-kind resources, resulting in the receipt of \$6,500 from the State of Tennessee.






