**Fund 101 - General Fund**

After some discussion, Commissioner Owen made the motion to tentatively approve the 2012-2013FY General Fund budget and set the tax rate at 61¢. A second was made by Commissioner Wright and the motion unanimously passed.

**Fund 116 - Solid Waste**

Commissioner Jones made the motion to tentatively approve the 2012-2013FY Solid Waste budget and with a second by Commissioner Salmon the motion unanimously passed.

**Fund 131 - Highway**

Commissioner Westbrook made the motion to tentatively approve the 2012-2013FY Highway budget and set the tax rate at 22¢ and with a second by Commissioner Jones the motion unanimously passed.

Commissioner Owen made the motion to tentatively set the 2013-2013FY tax rate for Weakley County, Tennessee at \$2.17 to be distributed as follows:

General Fund	\$0.61
Highway	\$0.22
Schools	\$0.74
Debt Service	\$0.60

and with a second by Commissioner Jones the motion unanimously passed.
