

RESOLUTION NO. 2013-02

RESOLUTION FIXING THE TAX LEVY FOR WEAKLEY COUNTY, TENNESSEE FOR THE FISCAL YEAR BEGINNING JULY 1, 2012.

SECTION 1. BE IT RESOLVED by the Board of County Commissioners of Weakley County, Tennessee, in a regular session on this the 30th day of July, 2012, that the combined property tax rate for Weakley County, Tennessee for the Fiscal Year beginning July 1, 2012, shall be \$2.17 on each \$100.00 of taxable property, which is to provide revenue for each of the following levies:

HIGHWAY	0.22
GENERAL PURPOSE SCHOOL	0.74
DEBT SERVICE	<u>0.60</u>
TOTAL	<u>\$ 2.17</u>


SECTION 2. BE IT FURTHER RESOLVED, that there is hereby levied a gross receipts tax as provided by law. The proceeds of the gross receipts tax herein levied shall accrue to the County General Fund.

SECTION 3. BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby rescinded.






Motion made by Commissioner Stewart that the foregoing resolution be adopted: Motion seconded by Commissioner Medling.
