

RESOLUTION 2013-04

RESOLUTION AUTHORIZING AN INCREASE IN THE JAILER'S FEE OF WEAKLEY COUNTY EFFECTIVE JULY 1, 2012.

WHEREAS, the Tennessee Code Annotated, Section 8-26-105, authorizes county legislative bodies to pass a resolution fixing the amount of jailer's fee which may be applied to misdemeanor prisoners for each calendar day the prisoner is confined to the local facility; and

WHEREAS, the Board of County Commissioners of Weakley County fixed the jailer's fee at \$35.00 per misdemeanor prisoner per calendar day of confinement by Resolution 1999-67; and

WHEREAS, the Board of County Commissioners of Weakley County desires to increase the jailer's fee from \$35.00 to \$37.00.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 30th day of July, 2012 in Dresden, Tennessee that:

SECTION 1. The jailer's fee for Weakley County is hereby increased from \$35.00 to \$37.00 per misdemeanor prisoner per calendar day of confinement.

SECTION 2. The jailer's fee herein is fixed and shall be collected by the clerk of the appropriate court, both county and municipalities, as part of the fines and costs imposed in each misdemeanor case upon filing of guilt.

SECTION 3. That a copy of this resolution be transmitted to all clerks of a court, both county and municipalities, hearing criminal matters in Weakley County and shall be spread upon the minutes of this meeting by the county clerk.

NOW THEREFORE BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee which are in conflict with this resolution are hereby repealed.






