

**RESOLUTION 2013-15**

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2013.**

**WHEREAS**, Weakley County Ned R. McWherter Library received a computer grant from USDA Rural Development during the 2011-2012 fiscal year and did not expense all the funds; and

**WHEREAS**, there are \$3,672 of grant funds remaining to be expensed for the purchase computer equipment, computer furniture, and to provide computer training classes to the public.

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 19<sup>th</sup> day of November, 2012 in Dresden, Tennessee that:




