

**RESOLUTION TO AUTHORIZE BUDGET AMENDMENTS TO THE GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2013.**

**WHEREAS**, the county legislative body, having established a county public records commission as required by law, established an archive and records management fee of \$2.00 per document effective January 1, 2013 as per Resolution #2013-14; and

**WHEREAS**, fee collections are estimated for the 2012-2013 fiscal year of \$20,683 and should be appropriated in the general fund budget.
