RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2014.

WHEREAS, the State of Tennessee Department of Health is returning the county saving funds that have been accumulating at the State level for numerous years; and

WHEREAS, Weakley County received the county saving refund of \$40,375.95; and

WHEREAS, these funds have been used to maintain and provide necessary repairs to the Weakley County Health Department and such maintenance and repairs are needed.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 18th day of November 2013 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund is hereby amended as follows:


