

RESOLUTION NO. 2014-16

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2014.

WHEREAS, Hope of Martin, Inc. is organized and operated exclusively for charitable and educational purposes as provided by Section 501(c) (3) of the Internal Revenue Code; and

WHEREAS, Hope of Martin, Inc. holds title to certain properties located on Meek and Highland Streets in the corporate limits of Martin, TN; and

WHEREAS, Hope of Martin, Inc. is requesting a donation from Weakley County in the amount of \$3,672.41 for the payment of county property taxes, including interest and penalty, on the properties as set out in Map 72B Parcel 3.00, 4.00, 4.01, 4.01-001, 5.00, 5.00-01 for tax years 2008 through 2013.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 18th day of November 2013 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund is hereby amended as follows:

These funds will be donated to Hope of Martin, Inc. with the understanding the purpose of the funds will be used to remit payment of \$3,672.41 to Weakley County for the payment of county property taxes, including interest and penalty, on the properties as set out in Map 72B Parcel 3.00, 4.00, 4.01, 4.01-001, 5.00, 5.00-01 for tax years 2008 through 2013.

SECTION 3. Hope of Martin, Inc. will certify and declare all such property is owned by them free and clear of liens or other claims and will be responsible for all future property taxes on these properties.

BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the, Board of County Commissioners.


