RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2014.

WHEREAS, the Weakley County Circuit and General Sessions Courts need to upgrade their computer system in order to continue to serve the people; and

SECTION 1. The Weakley County General Fund is hereby amended as follows:


