

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2015.**

**WHEREAS**, the State of Tennessee Office of Criminal Justice Programs has awarded the Weakley County Sheriff's Department a \$22,872 grant to undertake the Alcohol Countermeasures Highway Safety Project as defined in the Tennessee Highway Safety Plan which includes law enforcement activities to decrease the number of DUI crashes and to increase enforcement via area-wide saturation points, with no local match; and

**WHEREAS**, this alcohol open container grant will provide the Weakley County Sheriff's Department funding for the purpose of obtaining and maintaining equipment in the enforcement of alcohol related traffic offenses; and

**WHEREAS**, the grant funds will be used to purchase equipment to include: two in-car video camera systems and will provide funding for additional DUI checkpoint saturations throughout Weakley County.

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 17<sup>th</sup> day of November 2014 in Dresden, Tennessee that:
