

## RESOLUTION NO. 2017-06

### RESOLUTION AUTHORIZING THE WEAKLEY COUNTY HIGHWAY DEPARTMENT TO PERFORM WORK FOR OTHER GOVERNMENTAL ENTITIES

**WHEREAS**, Section 54-7-202, Tennessee Code Annotated (TCA), provides that the county legislative body has the authority to authorize the county highway department to perform work for other governmental entities, including other departments within county governments and municipalities in the county, so long as the highway department is reimbursed for the costs of the projects; and

**WHEREAS**, the county legislative body of Weakley County has determined that it is in the best interest of the public that the Weakley County Highway Department (Highway Department) perform the work specified below.

**NOW, THEREFORE BE IT RESOLVED**, by the County Legislative Body of Weakley County, Tennessee, meeting in regular session in Dresden, Tennessee, on this 19<sup>th</sup> day of September 2016, that:

**SECTION 1.** The Highway Department is hereby authorized to perform the work described herein for the City of Dresden Industrial Board.

**SECTION 2.** The Highway Department is authorized to transport and spread gravel to improve a parking area in the City of Dresden Industrial Park.

**SECTION 3.** Pursuant to Section 54-7-202(d) TCA, the Highway Department shall be reimbursed by the Dresden Industrial Board for all costs associated with the work described in Section 2 above.

**SECTION 4.** All requests for authorization to perform work shall be initiated with the chief administrative officer of the Highway Department who shall submit such requests, at his discretion, to the county legislative body for approval.

**SECTION 5.** For the purposes of approving or rejecting the provisions of this of this Resolution, it shall be effective upon being approved by a majority vote of the county legislative body of Weakley County, Tennessee.

**BE IT FURTHER RESOLVED** that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.




