

RESOLUTION NO. 1995-08

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY  
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1995

WHEREAS, the Weakley County Health Department has received authorization to construct a new facility to support the health and welfare of the citizens of Weakley County, and

WHEREAS, Community Development Block Grant funds in the amount of \$300,000 have been awarded to Weakley County for the purpose of constructing said health facility, and

WHEREAS, the State of Tennessee has awarded Special Needs Grants to Weakley County in the amount of \$156,550 (represented by prior year funding of \$101,000 and previously designated for Health and Welfare Projects plus current year funding of \$55,550) to aid in the construction of said health facility, and

WHEREAS, Weakley County has previously designated funds from local revenues in the amount of \$131,700 for Health and Welfare Projects, and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Weakley County, Tennessee, assembled in regular session on this 17th day of January, 1995, that: total funding in the amount of \$588,250 be appropriated for construction for the new Weakley County Health Department facility.

SECTION 1. The Weakley County Budget is hereby amended as follows:
