RESOLUTION NO. 1995-14

RESOLUTION AUTHORIZING CERTAIN CHANGES IN THE PARTICIPATION FOR THE WEAKLEY COUNTY EMPLOYEES GROUP INSURANCE PLAN

WHEREAS, Weakley County, Tennessee participates in an Employee Group Insurance Plan to help provide for the health and welfare of its employees and their families through the benefits of health, accident, and life insurance for the administrative and support personnel of the General County, Highway, and School Departments,

AND WHEREAS, the County presently pays an amount equal to 50% of the costs of said insurance coverage provided for the benefit of its employees and their spouses and dependents,

AND WHEREAS, the County now wishes to amend the percentages of the premium costs it pays to provide said coverage so as to pay an amount equal to 70% of the costs of the premium for employee health and life coverage, and to pay an amount equal to 45% of the cost of spouse and dependent health coverage.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 17th day of January, 1995 in Dresden, Tennessee that:

SECTION 1. The participation rates shall be amended to reflect the percentages as stated in the foregoing paragraphs of this resolution and that the effective date of said amendment shall be on the 1st day of February, 1995 or upon the effective date of the employee accident and health plan proposed by the Prudential Insurance Company under Bid # 95-06 dated September 16, 1994 whichever is later, and,

SECTION 2. BE IT FURTHER RESOLVED, that these changes will remain in effect for any subsequent accident and health plan that may be adopted or approved by this Commission or its agents acting within the authority of their offices or appointments, and shall remain in effect until such time as same may be amended or repealed by this body, and,

SECTION 3. BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed. This resolution shall be spread upon the minutes of the Board of County Commissioners.
