

RESOLUTION NO. 1997-40

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENN
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1997.**

WHEREAS, The Weakley County Commission approved funds in the original 1996-97FY budget for contributions to Emergency Communication (E-911) and offset by revenues of building permits; and

WHEREAS, it has now become necessary for these funds to be expended directly from the General Fund to purchase road signs and for contracted services in (Repairs and Maintenance); and

WHEREAS, any funds not expended at the end of each fiscal year from the revenues of building permits should be reserved in a designated account.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 21st day of January, 1997 in Dresden, Tennessee that the funds not expended at the end of each fiscal year will be reserved in a designated account:
