

Resolution No. 1999-04

A RESOLUTION TO SET THE ANNUAL SALARY OF THE JUDGE OF THE JUVENILE COURT OF WEAKLEY COUNTY

WHEREAS, Private Acts of 1982, Chapter No. 255, Section 6, provides that the salary of the Judge of the Juvenile Court of Weakley County shall be determined and set by the County legislative body; and

WHEREAS, the annual salary of the Judge of the Juvenile Court of Weakley County is presently \$15,000; and

WHEREAS, the duties of the Judge of the Juvenile Court of Weakley County have greatly increased and are expected to increase more in future years; and

WHEREAS, the Board of County Commissioners of Weakley County believes that it would be in the best interest of Weakley County to increase the salary of the Judge of the Weakley County Juvenile Court to \$25,000 per annum, effective September 1, 1998, and provide for annual increase thereafter.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Weakley County, Tennessee, assembled in regular session on this 27th day of July, 1998, that:

SECTION 1. The Board of County Commissioners of Weakley County, Tennessee, hereby sets the annual salary of the Judge of the Juvenile Court of Weakley County at \$25,000, effective September 1, 1998. On each July 1 thereafter, an annual adjustment be made to the salary based on the change in the average consumer price index, that being the same percentage raise provided to General Sessions Judges in T.C.A. Section 16-15-5003(f). For each two percent (2%) increase in the average consumer price index between two successive calendar years, the base salary is to be adjusted by one percent (1%), up to a maximum of four percent (4%).

SECTION 2. The Judge of the Juvenile Court of Weakley County is authorized to participate in the Tennessee Consolidated Retirement System.

SECTION 3. All resolutions on the Board of Commissioners of Weakley County, Tennessee, which are in conflict with this resolution, are hereby repealed.

SECTION 4. This resolution takes effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
