

Resolution No. 1999- 14  
 Resolution Authorizing Budget Amendments  
 To The General Purpose School Fund  
 For The Fiscal Year Ending June 30, 1999

WHEREAS, certain events have occurred requiring adjustments in the 1998-99 General Purpose School (Special Education) fund; and,

WHEREAS, a special education school bus needs to be lease purchased; furniture needs to be purchased for new special education classrooms; and an LPN is required to provide tube-feeding and medication assistance to special education students.

SECTION 1. The Special Education (State and Local) Fund is hereby amended as follows:


