RESOLUTION AUTHORIZING A ROAD ADDITION FOR THE
WEAKLEY COUNTY HIGHWAY DEPARTMENT

WHEREAS, a road herein named Cotham Rd. beginning at Highway 89 near Sharon, TN. and traveling south a distance of 1,151.70 ft. was added to the Weakley County Rural Road Maintenance System on October 17, 1994, by Resolution number 1994-63 of the Board of County Commissioners; and

WHEREAS, the Weakley County Board of Highway Commissioners passed resolution No. 2000-04 at its regular meeting of July 15, 1999, stating that a dispute has arisen concerning the County's right to maintain said road as a public road and asking this Commission to take action to have said road declared a public road or to condemn said road if necessary; and

RESOLUTION OF THE WEAKLEY COUNTY ROAD BOARD
REQUESTING CONDEMNATION OF A RIGHT OF WAY

WHEREAS, a road herein named Cotham Rd. beginning at Highway 89 near Sharon, TN. and traveling south a distance of 1,151.70 ft. was added to the Weakley County Rural Road Maintenance System on October 17, 1994, by Resolution number 1994-63 of the Board of County Commissioners; and

WHEREAS, a dispute as to the ownership of said right of way has arisen and the Weakley County Road Board seeks to resolve this dispute and maintain said road for public use; and

WHEREAS, it is necessary to condemn said forty foot easement or have same declared to resolve said dispute;

NOW, THEREFORE BE IT RESOLVED, that the Weakley County Road Board assembled in regular session on this the 15th day of July, 1999, does hereby request that the Board of County Commissioners condemn the forty foot easement for Cotham Rd. or have it declared so that all disputes may be resolved and said road maintained for public use.
