

RESOLUTION NO. 2000-09

RESOLUTION AUTHORIZING BUDGET AMENDMENT TO THE  
WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2000.

WHEREAS, certain events have occurred requiring adjustments in the 1999-2000 highway budget;  
and

WHEREAS, a transfer from fund balance is needed to complete the purchase of a new John Deere  
trackhoe; and

WHEREAS, a portion of these funds are available in the Highway Equipment line but a total of  
\$7,500 is needed to complete the purchase transaction; and

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee  
assembled in regular session on this the 20<sup>th</sup> day of September, 1999 in Dresden, Tennessee this resolution  
is hereby approved.

SECTION 1. The Weakley County Highway Fund is hereby amended as follows:




County Commissioners.




