

RESOLUTION NO. 2000-44

RESOLUTION AUTHORIZING BUDGET AMENDMENT
TO THE WEAKLEY COUNTY, TENNESSEE GENERAL FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 2000.

WHEREAS, the Weakley County Commission has approve renovations for the Weakley County Courthouse;
and

WHEREAS, funds have been appropriated for the construction and remodeling phases of the project; and

WHEREAS, the Weakley County Courthouse was erected in 1949 and it has been brought to the attention of
the county commissioners that the water pipe system should be renovated during the construction and remodeling
of the Weakley County Courthouse; and

WHEREAS, the elected officials and department heads have addressed the county commissioners requesting
an upgrade to the communication system in the Weakley County Courthouse; and

WHEREAS, the general fund has \$175,00 in excess funds that will not used in the 1999-2000 fiscal year,
therefore those funds will be transferred to the building improvements line for the \$139,783 water pipe renovation
and the \$20,000 communication upgrade

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee
assembled in regular session on this the 20th day of March 2000 in Dresden, Tennessee this resolution is hereby
approved.

SECTION 1. The Weakley County General Fund is hereby amended as follows:
