RESOLUTION MEMORIALIZING COMMISSIONER GEORGE BROUSSARD
AND REQUESTING THE GENERAL ASSEMBLY TO NAME
A BRIDGE IN HIS MEMEORY

WHEREAS, George Broussard was born January 28, 1935 and passed away on January 3, 2002;
and

WHEREAS, George Broussard was a dedicated family man, being married to Glenda Lee since
November 28, 1970 for over 31 years and had great love for and took great pride in his son, Stewart; and

WHEREAS, George Broussard served as a Weakley County Commissioner from 1978 to 1982 and
again from 1986 to the present; and

WHEREAS, George Broussard served as Mayor of the town of Sharon in 1979 and served for eight
years during which time the town made much progress; and

WHEREAS, George Broussard was an avid sportsman, duck hunter and gourmet connoisseur of
Cajun cuisine who loved the land the outdoors; and

WHEREAS, George Broussard grew up in Louisiana and worked on plantations in Mississippi and
British Honduras before coming to Weakley County; and

WHEREAS, he was well known and much loved in his adopted county.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County,
Tennessee assembled in regular session on this the 22nd of January 2002 in Dresden, Tennessee that :

George Broussard is recognized and honored for his many years of contributions to the State of
Tennessee and Weakley County and for his years as a dedicated husband, father, and community leader.

BE IT FURTHER RESOLVED, that the Tennessee General Assembly is requested to enact
legislation to name the bridge on State Route 43 over the Middle Fork of the Obion River between Sharon
and Greenfield the "George Broussard Memorial Bridge." (Federal Route 45E)

BE IT FURTHER RESOLVED, that a suitable copy of this Resolution be sent to Mr. Broussard's
family and that copies be sent to Senator Roy Herron and State Representative Mark Maddox.



BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public


