

RESOLUTION NO. 2002-47

RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN GENERAL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2002.

WHEREAS, the Veteran Service Officer Search Committee recommended the hiring of William D. Bradley as the Weakley County Veteran Service officer on September 21, 1998; and

WHEREAS, Mr. Bradley was formerly employed at the Weakley County Nursing Home from June 14, 1993 until his employment as the Veteran Service officer on October 1, 1998; and

WHEREAS, the Health, Education, & Welfare Committee approved for Mr. Bradley's sick and vacation time to be transferred from the Weakley County Nursing Home on March 11, 1999; however Mr. Bradley's longevity time was not transferred; and

WHEREAS, the Health, Education, & Welfare Committee and the Personnel Committee have approved the transfer of Mr. Bradley's longevity time and the accumulated longevity payment of \$1,200.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 20<sup>th</sup> of May 2002 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund is hereby amended as follows:


