

RESOLUTION NO. 2002-49
A RESOLUTION TO APPROVE PRIVATE CHAPTER 117
PRIVATE ACTS OF 2002, RELATIVE TO THE COMPENSATION
OF THE COUNTY HIGHWAY COMMISSION OF WEAKLEY COUNTY

WHEREAS, the Weakley County Commission, meeting in regular session March 18, 2002 resolved by a two-thirds (2/3) vote of the Commission to request the members of the General Assembly representing Weakley County to introduce and work for the passage of the private act which would increase the compensation of the Board of Highway Commissioners of Weakley County from \$200.00 to \$300.00 per month, and

WHEREAS, the General Assembly of the State of Tennessee has approved the foregoing request from the Weakley County Commission as follows: Section 3 of Chapter 640 of the Private Acts of 1949, as amended by Chapter 250 of the Private Acts of 1953, Chapter 24 of the Private Acts of 1995, and any other acts amendatory thereto, is further amended by deleting the language "which compensation shall not be less than two hundred dollars (\$200) per month" and by substituting instead the language "which compensation shall not be less than three hundred dollars (\$300) per month for any term beginning on September 1, 2002".

NOW, THEREFORE, BE IT RESOLVED by a two-thirds (2/3) vote of the county legislative body of Weakley County, Tennessee in regular session on this 20th day of May 2002, that Private Chapter No. 117, Private Acts of 2002, is approved. The approval shall be proclaimed by the presiding officer of the legislative body and certified to the Secretary of State.

BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

BE IT FURTHER RESOLVED, that this resolution shall take effect upon passage by a majority of the members of the Board of County Commissioners of Weakley County.
