

RESOLUTION 2002 - 51

TO AUTHORIZE THE WEAKLEY COUNTY CLERK
TO COLLECT A MOTOR VEHICLE REGULATORY FEE
IMPOSED BY THE CITY OF DRESDEN

WHEREAS, Tennessee Code Annotated, Section 7-51-703, authorizes the county clerk of any county and any municipality located wholly or in part in such county by resolution of its governing body to enter into an agreement with such terms as may be agreed upon, including appropriate compensation, providing for the county clerk to collect for such municipality motor vehicle regulatory fees imposed by such municipality and;

WHEREAS, Tennessee Code Annotated, Section 7-51-703, requires the approval of such agreement by the county legislative body and;

WHEREAS, the Weakley County Legislative Body finds it is in the best interests of the residents of Weakley County and the City of Dresden to provide for the Weakley County Clerk to collect such municipal motor vehicle regulatory fees provided that the City of Dresden provide the County Clerk with the appropriate decals.

NOW, THEREFORE, BE IT RESOLVED by the Weakley County Legislative Body meeting in Regular Session at Dresden, Tennessee, on this 24th day of June, 2002, that:

SECTION 1. BE IT FURTHER RESOLVED, the Weakley County Clerk is authorized, pursuant to Tennessee Code Annotated, Section 7-51-703, to collect the motor vehicle regulatory fees imposed by the City of Dresden.

SECTION 2. BE IT FURTHER RESOLVED, that for such services, the County Clerk shall be entitled to a one dollar (\$1.00) fee per sticker issued and a five percent (5%) commission on all motor vehicular regulatory fees collected for the City of Dresden.

SECTION 3. BE IT FURTHER RESOLVED, such practice is hereby made permanent until such time as Weakley County and the City of Dresden seek to terminate such arrangement.

SECTION 4. BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

SECTION 5. BE IT FURTHER RESOLVED, that this resolution shall take effect upon passage by a majority of the members of the Board of County Commissioners of Weakley County, Tennessee.
