RESOLUTION AUTHORIZING SUBMISSION OF AN APPLICATION FOR A LITTER AND TRASH COLLECTING GRANT FROM THE TENNESSEE DEPARTMENT OF TRANSPORTATION AND AUTHORIZING THE ACCEPTANCE OF SAID GRANT TO THE WEAKLEY COUNTY, TENNESSEE, HIGHWAY FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2003

WHEREAS, Weakley County intends to apply for a Litter and Trash Collecting Grant from the Tennessee Department of Transportation; and

WHEREAS, the contract for the grant will impose legal obligations upon Weakley County.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 24th day of June, 2002 in Dresden, Tennessee that:

SECTION 1.

- 1. Ron Gifford, County Executive is authorized to apply on behalf of Weakley County, for a Litter and Trash Collecting Grant from the Tennessee Department of Transportation, approximately \$26,247.
2. Should said application be approved by the Tennessee Department of Transportation then Ron Gifford, County Executive is authorized to execute contracts or other necessary documents, which may be required to signify acceptance of the Litter and Trash Collecting Grant by Weakley County.
