

**RESOLUTION NO. 2002-63**

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE  
WEAKLEY COUNTY, TN GENERAL FUND FOR THE  
FISCAL YEAR ENDING JUNE 30, 2002.**

**WHEREAS**, the Tennessee Department of Transportation Governor's Highway Safety Office has awarded the Weakley County Sheriff's Department a grant in the amount of \$6,000; and

**WHEREAS**, the grant funds will be utilized to purchase video equipment to be place in sheriff department vehicles and to be used for crime scene investigation; and

**WHEREAS**, the grant is a reimbursement grant expiring on June 30, 2002.

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 24<sup>th</sup> day of June, 2002 in Dresden, Tennessee that:




