

RESOLUTION 2003-04

A RESOLUTION TO APPOINT A COMMITTEE ON RULES OF THE WEAKLEY COUNTY BOARD OF COMMISSIONERS

WHEREAS, the County Board of Commissioners has such a committee in place, and the need may arise to amend said rules and with the need to appoint committees of the Weakley County Board of Commissioners; and

WHEREAS, there will be new County Commissioners elected in the August 1, 2002, General Election; and

WHEREAS, these new officials, as well as the incumbent officials and the general public, need to be knowledgeable of the rules, procedures, and committees of the county legislative body.

NOW, THEREFORE, BE IT RESOLVED by the Weakley County Legislative Body meeting in Regular Session at Dresden, Tennessee, on this 19th day of August, 2002, that:

SECTION 1. Nine (9) County Commissioners be appointed to serve on a committee to study the rules, procedures, and committee structure of the county legislative body, to make recommendations for committee assignments and to make nominations to fill offices as required by law to be filled by the County Commission.

SECTION 3. The first meeting of the committee will be at 2:30 P.M. in the County Courthouse on Friday, August 30, 2002. The County Executive and the County Clerk are directed to advise the news media and all interested parties of the meeting in full compliance with the state open-meeting law.

SECTION 4. The committee shall report their recommendations to the county legislative body at the first meeting, whether regular or called, held on or after August 30, 2002. The committee report shall be the first item of business considered at such meeting and in case of a called meeting the committee report shall be included in the call.
