

RESOLUTION NO. 2010-17

RESOLUTION AUTHORIZING A CAP ON THE JAILER'S FEE OF WEAKLEY COUNTY, TN.

WHEREAS, Tennessee Code Annotated, Section 8-26-105 authorizes county legislative bodies to pass a resolution fixing the amount of jailer's fees which may be applied to misdemeanor prisoners for each calendar day the prisoner is confined to the local facility; and

WHEREAS, the Weakley County Board of County Commissioners fixed the jailer's fees at \$35.00 per misdemeanor prisoner per calendar day of confinement by Resolution 1999-67; and

WHEREAS, the Weakley County Board of County Commissioners desires to cap the jailer's fee for misdemeanor prisoner at \$350 per period of incarceration.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 16th day of November, 2009 in Dresden, Tennessee that:

SECTION 1. The maximum jailer's fee for a misdemeanor prisoner be capped at \$350 per period of incarceration.

SECTION 2. The jailer's fees herein fixed shall be collected by the clerk of the appropriate court as a part of the fines and costs imposed in each misdemeanor case upon a finding of guilt.


SECTIONS 3. A copy of this resolution shall be transmitted to each clerk of a court hearing criminal matters in Weakley County and shall be spread upon the minutes of this meeting by the county clerk.

NOW, THEREFORE BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.




