

RESOLUTION 2011-05

A RESOLUTION TO APPOINT A RULES COMMITTEE OF THE WEAKLEY COUNTY BOARD OF COMMISSIONERS

WHEREAS, the County Board of Commissioners has such a committee in place, and the need may arise to amend said rules and with the need to appoint committees of the Weakley County Board of Commissioners; and

WHEREAS, members of the County Commission will be elected in the August 5, 2010, general election; and

WHEREAS, new officials, as well as incumbent officials and the general public, need to be knowledgeable of the rules, procedures and committees of the county legislative body.

NOW THEREFORE, BE IT RESOLVED by the Weakley County Legislative Body meeting in regular session on this 26th day of July, 2010, that:

SECTION 1. Nine (9) County Commissioners be appointed to serve on a committee to study and recommend the rules, procedures, and committee structure of the county legislative body, to make recommendations for committee assignments and to make nominations to fill offices as required by law to be filled by the County Legislative Body.

SECTION 2. The committee members appointed shall be as follows:


In the event John Salmon is not reelected in District 1, David Rook is appointed. In the event C. Richard Phebus is not re-elected in District 5, Larry W. Taylor is appointed. In the event Bob Bell is not re-elected in District 7, the person receiving the most votes in the general election is appointed as a member of the Rules Committee.

SECTION 3. The first meeting of the committee will be immediately following the 8:00 a.m. swearing-in ceremony to be held in the Weakley County Commission Courtroom on Wednesday, September 1, 2010.


