

RESOLUTION NO. 2011-37

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO HE WEAKLEY COUNTY, TN
HIGHWAY FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2011.

WHEREAS, the 2010 U.S. census has been completed and certified resulting in the population count of Weakley County increasing to 35,021; and

WHEREAS, Weakley County's increase in population changes the class for calculating county official's salaries; the new population classification will be effective April 2010, changing the minimum salary for county officials as of April 2010; and

WHEREAS, the county official's salary must be adjusted for the time period of April 2010 through June 2011; and

WHEREAS, the Weakley County Highway Fund budget 10-11FY is in need of realignment in estimated local expenditures.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 23rd day of May, 2011 in Dresden, Tennessee that:
