

RESOLUTION 2012-37

RESOLUTION AUTHORIZING ACCEPTANCE OF A GRANT FOR THE WEAKLEY COUNTY PUBLIC RECORDS COMMISSION FROM THE STATE OF TENNESSEE FOR THE FISCAL YEAR ENDING JUNE 30, 2012.

WHEREAS, the Weakley County Public Records Commission applied for and was awarded a grant to be used for preserving and providing access to Weakley County historical records; and

WHEREAS, the grant contract, in the amount of \$5,000.00 will be used to purchase supplies such as shelving, document cases, HEPA vacuum, filters and bags, small tools to be used to properly maintain the records.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 29th day of May 2012 in Dresden, Tennessee that:




