

RESOLUTION 2012-39

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2012.

WHEREAS, the Weakley County Courthouse roof is leaking and causing damage to various Courthouse offices and has been for sometime; and

WHEREAS, sealed bids have been solicited and the cost to install a new silicone roof with a twenty year warranty is \$78,000; and

WHEREAS, the Everett Stewart Regional Airport has requested an additional contribution \$2,100 to help fund the cost of installing a new well, Obion County is matching the contribution.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 29th day of May 2012 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund is hereby amended as follows:


