
SENATE BILL NO. 742 was presented to the Court for Action.

An Act to amend Chapter No. 224 of the Private Acts of 1933.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE,

That Section 2, Chapter No. 224, Private Acts 1933, be and the same is hereby amended by deleting, after the words "The Following Civil Districts" the following words and figures, "Zone No. 1--Districts Nos. 1, 13, 17; Zone No. 2--Districts Nos. 19, 3, 2 and 14; Zone No. 3---Districts Nos. 23, 12 and 11; Zone No. 4--Districts Nos. 10, 8 and 7; Zone No. 5---Districts Nos. 5, 24, 25 and 6; Zone No. 6--Districts Nos. 22, 9, 15 and 16; Zone No. 7--Districts Nos. 18, 20 and 4," and in lieu thereof insert the following words and figures, to-wit: "Zone No. 1--Districts Nos. 13 and 17; Zone No. 2--Districts No. 2, 3, 14 and 18; Zone No. 3---Districts Nos. 11, 12, and 23; Zone No. 4---Districts Nos. 6, 7 10 and 24; Zone No. 5---Districts Nos. 1, 5 and 25; Zone no. 6--Districts Nos. 9, 15, 16 and 22; Zone No. 7--Districts Nos. 4 and 20; Zone No. 8--Districts Nos. 8 and 19"

SECTION 2. BE IT FURTHER ENACTED, That Section 3, Chapter 224, Private Acts 1933, be and the same is hereby amended by adding the following paragraph to that Section.

"Roy B. Crowder shall act as Board Member for School Zone No. 8 from and after the passage of this Bill and ratification of the same by the County Court. His term of office shall extend to the regular August Election in 1956 at which time a Board member shall be elected as provided by this Act, and he shall be elected in the same manner as other Board Members and shall hold his term of office for the same period of time that they hold theirs for. All of which is provided for in this Act."

SECTION 3. BE IT FURTHER ENACTED, That this Act shall take effect from and after its passage, the public welfare requiring it.
