BUDGET HEARING FOR REVENUE SHARING PURPOSES: Motion to accept this purpose made by Comm. Joe White and seconded by Comm. Charles Culver. After a poll call vote, motion carried.

GENERAL FUND REPORT: Motion to accept the General Fund report made by Comm. Charles Culver and seconded by Comm. James H. Bell. After a show of hands vote, motion carried.

HIGHWAY DEPT. REPORT: Motion to accept the highway dept report made by Comm. Bobby Parker and seconded by Comm. Wm. Mansfield. After a show of hands vote, motion carried.

SCHOOL DEPT REPORT: Motion to accept the school dept report made by Comm. V. J. Shanklin and seconded by Comm. James H. Bell. After a show of hands vote, motion carried.

NURSHING HOME REPORT: Motion to accept the Nursing Home Report made by Comm. Joe White and seconded by Comm. Wm. S. Powers. After a show of hands vote, motion carried.

PROPERTY COMMITTEE REPORT: Comm. Wm. H. Mansfield told the Commissioner that on June 26, 1985, the Property Committee convened to let out insurance bids for liability insurance on county vehicles. We had 2 bids submitted one from the Dresden Insurance Co. and the other from Fullers at Martin. He also told about the roofs and the bleachers. Motion to accept his report was made by Comm. PERSONNEL COMMITTEE REPORT; Comm. Charles Culver, chairman of the Personnel committee, told the Comm. of his meeting with the Courthouse Employees and some employees of the Sheriffs dept. There were 3 items in which they wanted the Personnel Committee to look into. 1. Ins., 2. longevity pay, 3. Raises. The Personnel Committee will look into this and get back with the employees. Motion to accept the report was made by Comm. Earl Wright and seconded by Comm. James H. Bell. After being put to a show of hands vote, motion carried.

HEW REPORT: The HEW Committee met with Billy Joe Harrison to reissue a contract to operate the landfill for a 5 year term. Mr. Harrison also ask the committee to look look into the possibility of awarding him a permit to pick up and handle commerical and industrial waste in the county from factories and wherever. We will probably need the county attorneys ruling on this as we also have a person picking up from Commerical places already. Motinn to accept this report was made by Comm. Gene Harris and Comm Wm. Mansfield seconded. After a show of hands vote, motion carried.

AMBULANCE COMMITTEE REPORT: Comm. Earl Wright told the Commissioners they discussed the level of cost and service and everything is going just fine. Motion to accpct this report was made by Comm. Sherman Powers and seconded by Comm. Larry Jolley.
