

**RESOLUTION NO. 1997- 63  
RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE  
WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 1997**

WHEREAS, certain events have occurred requiring adjustments in the 1996-97 Highway Fund Budget, Fund #131 and,

WHEREAS, many roads and large culverts have been permanently damaged by the recent large amount of rain and funds are desperately needed for repair.

WHEREAS, certain events have caused other line items to be in need of funds due to the supply and demand of these items for the maintenance of county roads.

NOW, THEREFORE BY IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 17<sup>th</sup> day of March, 1997 in Dresden, Tennessee that:
