

RESOLUTION NO. 1997-78

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENN
SOLID WASTE FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1997.**

WHEREAS, the Solid Waste Fund in cooperation with the Weakley County Highway Department started a convenience center for Weakley County, and;

WHEREAS, the Solid Waste Fund is to reimburse the Weakley County Highway Department for expenses incurred for the convenience center, and;

WHEREAS, purchases for the Waste Convenience Center are subject to an 80% reimbursement from the Tennessee Department of Environment and Conservation Convenience Center Grant, and;

WHEREAS, additional line items are needed for expenses incurred for this fund.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 23rd day of May, 1997 in Dresden, Tennessee that:

SECTION 1. The Weakley County, Solid Waste Fund is hereby amended as follows:
