

**RESOLUTION NO. 1998-16**

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENN  
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1998.**

**SECTION 1.** The Weakley County, General Fund is hereby amended as follows:






