

**RESOLUTION NO. 1999-38**

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN GENERAL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 1999.**

**WHEREAS**, the Weakley County Adult Activities Center have received \$6,500.00 in federal and state funds for the Long Term Care Services; and

**WHEREAS**, the Addendum 1 to the Contract between Northwest Tennessee Area Agency on Aging and the Weakley County Board of Commissioners addresses special funding to provide Long-Term Care service to the Weakley County area; and

**WHEREAS**, the Long-Term Care service to be provided is Homemaker/Respite Care. Units of Service and Unduplicated Persons will be reported to the Northwest Tennessee Area on Aging. Units of Service provided and Unduplicated Persons served funded by other Federal, State, or Local funds will also be reported; and

**WHEREAS**, the funding will be \$5,000.00 for the salary/fringes of the homemaker. Expenses will be reported monthly to Northwest Tennessee Development. Other Federal, State, or Local funds used for Long-Term Care services will also be reported; and

**WHEREAS**, an additional \$400.00 will be used to purchase additional supplies and materials. An additional \$1,100.00 will be used to purchase an adding machine, a filing cabinet, a storage cabinet, and card tables; and

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 19th day of January, 1999 in Dresden, Tennessee that:

**SECTION 1.** The Weakley County, General Fund is hereby amended as follows:


