

RESOLUTION AUTHORIZING BUDGET AMENDMENT TO THE WEAKLEY COUNTY, TENNESSEE GENERAL FUND FOR THE YEAR ENDING JUNE 30, 2000.

WHEREAS, due to election of a new Circuit and General Session Clerk, the State of Tennessee Office conducted two special audits, totaling \$4,825.00; and

WHEREAS, a special purpose audit on the Consolidated Service Station, Highway Department, School Department, and the Finance Department was conducted at a charge of \$8,382.00; and

WHEREAS, the regular fiscal year audit conducted by the Comptroller's Office totaled \$7,344.00; and

WHEREAS, due to the four audits conducted by the State of Tennessee Comptroller's Office the audit services line is insufficient; and

WHEREAS, an increase of sixteen dollars (\$16) for the National Association of Counties 2000 membership dues is necessary; and

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 12th day of June 2000 in Dresden, Tennessee this resolution is hereby approved.

SECTION 1. The Weakley County General Fund is hereby amended as follows:
