

RESOLUTION NO. 2001-19

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS
TO THE WEAKLEY COUNTY, TN GENERAL FUND &
TO THE WEAKLEY COUNTY, TN HIGHWAY FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 2001.**

WHEREAS, the southern half of Weakley County suffered severe wind and electrical storms on May 23-27, 2000 resulting in wind generated debris on public right of ways, severe wind generated vegetative debris along 50 miles of county highway right of ways resulting in the closing of 68 county highways, and damaged electrical equipment and computers; and

WHEREAS, these wind and electrical storms caused damaged to various Weakley County communities estimating \$18,955; and

WHEREAS, the Weakley County Highway Department, the Weakley County Sheriff Department, the Weakley County Emergency Management personnel, the Weakley County Rescue Squad, along with the Sharon and Sidonia volunteer fire departments responded instantaneously to assist Weakley County; and

WHEREAS, Weakley County has received a disaster relief grant from the Tennessee Emergency Management Agency in the amount of \$18,955 to be distributed as compensation to the above mentioned departments; and

WHEREAS, the Weakley County General Fund and the Weakley County Highway Fund should be amended in receipt of this disaster relief grant; and

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 20th day of November 2000 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund and the Weakley County Highway Fund are hereby amended as follows:
