

RESOLUTION NO. 2001-25

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS
TO THE WEAKLEY COUNTY, TN GENERAL FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 2001.**

WHEREAS, General Fund expenditures have exceeded the estimated budget for the 00-01FY; and

WHEREAS, the building and contents insurance premium for the Courthouse should reflect \$8,615 in the 00-01FY budget; and

WHEREAS, the National Association of Counties membership dues increased from \$579 to \$586; and

WHEREAS, a vacant position was filled at the Weakley County Health Department after the passage of the 00-01FY budget, the employee chose the Weakley County Health Insurance plan; and

WHEREAS, Weakley County's autopsies and ambulances requests have significantly increased since the passage of the 00-01FY budget, an estimation of \$10,000 is needed to complete the budget year.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 16th day of January 2001 in Dresden, Tennessee that:
