

RESOLUTION NO. 2001-28

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS
TO THE WEAKLEY COUNTY, TN GENERAL FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 2001.**

WHEREAS, Weakley County did not receive the Local Law Enforcement Block Grant (LLEBG) for the 1999-2000 fiscal year; and

WHEREAS, Weakley County is eligible to receive the LLEBG funds for the 1999-2000 fiscal year in the amount of \$10,106; and

WHEREAS, this LLEBG program is a formal program based on a jurisdictions number of Uniform Crime Report Part I violent crimes reported to the Federal Bureau of Investigation; and

WHEREAS, Weakley County is required to match the LLEBG funds by 10% in the amount of \$1,011.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 16th day of January 2001 in Dresden, Tennessee that:

SECTION 1. The Weakley County, General Fund is hereby amended as follows:




