

RESOLUTION NO. 2001-40

RESOLUTION TO ESTABLISH A DRIVERS EDUCATION COURSE,
TO LEVY FEE PURSUANT TO T.C.A. , SECTION 55-10-301
AND TO SEEK APPROVAL FROM THE DEPARTMENT
OF SAFETY TO OFFER THE SAME

WHEREAS, Section 55-10-301 Tennessee Code Annotated, provides that upon Court Order a person violating any provisions of Chapters 8 and 9 of Tennessee Code Annotated Title 55 and parts 1 through 5 of Chapter 10 may be ordered in the Courts discretion to attend a Drivers Education Course approved by the Department of Safety in addition to or in lieu of any portion of other penalty imposed; and

WHEREAS, the County of Weakley is desirous of establishing and making available such program through its Sheriff's Department and levying of fees as provided for in said statutes for such participants as to each participant in such program; and

WHEREAS, by statute such fee shall not exceed fifty dollars (\$50.00); and

WHEREAS, it is the desire of Weakley County in offering such course to access the fee at fifty dollars (\$50.00) which fee shall apply only to the driver improvement courses required by T.C.A. Section 55-10-301; and

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 26th day of March 2001 in Dresden, Tennessee that:

SECTION 1. That there is hereby created for the County of Weakley a Drivers Education Course as provided for in T. C. A. Section 55-10-301 which serves shall be provided through the Weakley County Sheriff Department.

SECTION 2. That there is a fee accessed as to each participant of fifty dollars (\$50.00) as provided for by T. C. A. Section 55-10-208 subject, however, to the provision that no participant shall be refused admittance for inability to pay.

SECTION 3. This program shall take effect thirty (30) days from and after approval by the Department of Safety but in no event later than July 1, 2001.

BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.




