

**RESOLUTION NO. 2001-46
RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE
WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 2001**
