

RESOLUTION NO. 2001-52

RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN GENERAL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2001.

WHEREAS, the Weakley County Sheriff's Department is requesting the transfer of funds to purchase radio equipment and digital cameras; and

WHEREAS, the Weakley County Sheriff purposes to transfer \$3,999.87 from the Weakley County Jail budget #54210 to the Weakley County Sheriff Department budget #54110; and

WHEREAS, these funds were received from the Local Law Enforcement Block Grant (LLEBG) to be expensed for one time expenditures; and

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 21<sup>st</sup> day of May 2001 in Dresden, Tennessee that:






