

RESOLUTION NO. 2001-58

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS
TO THE WEAKLEY COUNTY, TN GENERAL FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 2001.**

WHEREAS, the Weakley County Clerk is requesting the purchase of two computer printers; and

WHEREAS, the marriage license and business tax printer and the vehicle registration printer are no longer working properly and must be replaced; and

WHEREAS, this is an unanticipated expenditure, the funds to purchase these computer printers were not included in the County Clerk's 00-01 FY budget, however funds can be transferred within the County Clerk's 00-01 FY budget to allow for this expenditure; and

WHEREAS, it has been recommended that chair mats be purchased for use on the new tile floors in the Courthouse in order to maintain the floor finish; and

WHEREAS, the County Clerk is requesting \$1,500 be transferred in the 00-01 FY budget.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 21st day of May 2001 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund is hereby amended as follows:
