

RESOLUTION NO. 2002-21

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS
TO THE WEAKLEY COUNTY, TN GENERAL FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 2002.**

WHEREAS, on October 23, 2001, Weakley County has approved a nine district reapportionment plan; and

WHEREAS, due to the reapportionment plan, the registration records of nearly all registered voters in Weakley County must be changed and new voter registration cards issued to each registered voter; and

WHEREAS, such extensive changes in the district numbers as well as district lines were not anticipated in preparing the Election Commission 01-02FY budget; therefore the Election Commission 01-02FY budget must be amended \$2,200; and

WHEREAS, due to the County Primary being held in May 2002, with a qualifying deadline of February 21, 2002, the Election Commission is requesting funds to purchase ArcView software and a small color printer for approximately \$1,500 from the State of TN contract; and

WHEREAS, the funds to purchase the ArcView software and color printer are available in the 01-02FY budget; however the line item adjustments are necessary.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 19th day of November 2001 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund is hereby amended as follows:






