

RESOLUTION NO. 2002-27

RESOLUTION AUTHORIZING ROAD NAME CHANGE
FROM A SECTION OF HERMAN BROOKS RD.
TO MELODY DRIVE

WHEREAS, Resolution No. 1997-32 provides that a road may be petitioned for name change when petition for such change contains the signatures of eighty percent (80%) of landowners residing on said roads along with a statement of agreement to the proposed change. Only one signature per parcel of land adjoining said road or roads will be recognized as counting toward the number of signatures required. *Exhibit A attached.

WHEREAS, a section of Herman Brooks Rd. is now petitioned to be changed to Melody Drive and upon passage will hereafter be called by that name.

NOW, THEREFORE BE IT RESOLVED, that the Weakley County Board of Commissioners, assembled in regular session on this the 19th of November, hereby changes the section of Herman Brooks Rd. to Melody Drive.

BE IT FURTHER RESOLVED, that this section of road is designated on the attached map. *Exhibit B and this change was approved by the 911 Board on Oct. 23, 2001.

BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
