

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS
TO THE WEAKLEY COUNTY, TN GENERAL FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 2003**

WHEREAS, the Weakley County Office on Aging and Sharon Senior Center has received \$4,688 of state funds that were with held during the State of TN budget crisis; and

WHEREAS, the Weakley County Office on Aging received \$1,473, the Sharon Senior Center received \$3,215; and

WHEREAS, these funds should be placed back into the respective line items in the 2002-03 fiscal year budget.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 19th of May 2003 in Dresden, Tennessee that:






