

**RESOLUTION NO. 2004-12**

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN GENERAL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2004**

WHEREAS, the Weakley County Emergency Management Office has received a grant in the amount of \$40,000 from the State of Tennessee Emergency Management Association; and

WHEREAS, the purpose of the grant is to provide radio equipment upgrades to the local law enforcement, fire departments and emergency medical services; and

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 17<sup>th</sup> of November 2003 in Dresden, Tennessee that:
