

RESOLUTION NO. 2006-07
RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE
WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 2006

WHEREAS, a budget amendment is necessary to increase the unemployment line; and

WHEREAS, this is due to the lack of funds which caused a temporary layoff in last fiscal year and funds in the new budget were not sufficient to cover the cost.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 19th day of Sept. 2005 in Dresden, Tennessee that this resolution is hereby approved for funds to be transferred from the following lines.

SECTION 1. The Weakley County Highway Fund is hereby amended as follows:
